1. Context

Women's labour force participation has increased in several countries over the past years (Hanna, et al., 2023). However, women remain underrepresented in managerial or leadership positions in both the private and public sector (though the share is higher in the public sector). Globally for year 2023, women held approximately 28% of managerial positions in the workplace (UN Women, 2023; UN-Women and DESA, 2024).

There is considerable regional variation behind women's participation in leadership positions. According to data from the United Nations Statistics Division (2022), Northern America and Europe has a share of approximately 38%, Latin America and the Caribbean of 36.3%, while North Africa has the lowest share (12.6%). Moreover, when in managerial positions, this is more likely in economic sectors that are female-dominated such as education, health and social work, than in male-dominated industries (ILO, 2020).

In Latin America and the Caribbean, even though women make up more than half of the population, they represent low percentages in leadership and decision-making positions. Women only represent 15.4% of mayoralties (2021), 32.7% of councillors (2021), 27.2% of seats in the deliberative bodies of local governments (2023) (ECLAC and UN Women, 2024), 35.8% of seats in national parliaments (2024) (ECLAC, 2024), and 36.3% in management positions (2022) (ECLAC-United Nations, 2024).

This situation is also reflected in leadership and senior positions in National Statistical Offices (NSO). According to a report by the Partnership on Statistics for Development in the 21st Century (PARIS21) in 2021, globally, less than a quarter of senior leadership positions (chief statistician or similar) in NSO were women. In Latin America and the Caribbean, as of 2024, there are 13 women in managerial positions in NSOs (director, or chief) out of a total of 33 countries and territories. In this context, where there are still challenges for the participation of women in decision-making and leadership spaces, both in general and specifically for the NSOs, it is important to enhance the leadership skills of women who are already in these decision-making positions and prepare those that are on their way.

A strategy on promoting the importance of gendered data, and with this, women's leadership in statistics and NSOs, is the podcast "Descifrando" (Deciphering in English), a joint initiative between the national statistical offices of the Dominican Republic and Colombia, ECLAC and UN Women. The podcast, launched in 2024 and originally in Spanish, sheds light on the importance of data with a gender perspective. This joint effort by multiple organizations reflects the ongoing commitment of Latin America and the Caribbean to promoting gender equality through high-quality data and statistics.

Empowering women within the leadership of national statistical offices (NSOs) is essential across all organizational levels, particularly in decision-making roles. There is a global need to foster and promote





















gender equality in statistical leadership as well as ensuring that women in leadership roles are empowered to fully contribute to the success of their organisations. NSO leaders face multiple pressures, however for female leaders these challenges can be even greater. It is essential to address the specific challenges faced by female NSO leaders and create a conducive environment that empowers and encourages female leaders within NSOs.

In this regard, the Community of Female Leaders of the NSOs of Latin America and the Caribbean, the Knowledge Transfer Network of the Statistical Conference of the Americas, ECLAC, UN Women, ESCAP, UNECE, UNSD, Data 2x jointly co organize this event to identify and strengthen the necessary skills to promote the participation and permanence of women in management positions within the National Statistics Offices.

2. Objective of the event

The event aims to shed light on gender inequality in NSO leadership positions, pathways for achieving gender equality, and how various leadership development initiatives can strengthen the capabilities of women in NSOs, highlighting the importance of sustaining and institutionalizing these efforts to ensure lasting and structural changes. This session will be an opportunity to explore the barriers and opportunities for promoting female leadership within NSOs.

Miosotis Rivas-Peña, Director-General of the National Statistics Office of the Dominican Republic

She has held the position of General Director of the National Statistics Office of the Dominican Republic since August 2020. She has a degree in economics with master's degrees in Economic Policy, Gender and Development and Human Development. She has extensive work experience in the Central American and Caribbean region in matters of regional integration, development and public policies, public equality policies, gender mainstreaming and trade negotiations. From 2023 is the Chair of the Executive Committee of the Statistical Conference of the Americas. In 2022, in coordination with the NSO Director General of Chile and the President of INEGI, Mexico, she launched the Community of Women Leaders of the National Statistics Offices as a space for support, and generation of resources and networks for women's leadership.



Rolando Ocampo, Chief of the Statistics Division of the United Nations Economic Commission for Latin America and the Caribbean (ECLAC).

He has led the position of Chief of the Statistics Division of ECLAC since August 2019. He is an Actuary graduated from Universidad Nacional Autónoma de México (UNAM). Master in Statistics from the Universidad Complutense of Madrid and master's in economics of education and labor from the Universidad Carlos III of Madrid.
