Main Objective: Strengthen statistical systems to produce gender statistics aligned with national priorities and the Agenda 2030

Project value: 1,53 mln USD

Timeline: 2018-2021

Countries: 9 (2 in 2018-2019 and 7 in 2019-2020)

Project contributes to 2 of the 3 outcomes of the wider UN WOMEN MEWGC initiative

Outcome 1. Support to improve the policy environment

Outcome 2. Increase data production

Outcome 3. Promote data availability and use

Project Activities

- A1. Improvement in co-ordination and planning** for gender statistics: gender statistics gaps assessment framework using PARIS21 tools, National Strategy Development of Gender Statistics integrated in NSDS, and gender statistics module in the NSDS Guidelines.
- A2. Improvement in data dissemination and communication** of gender statistics through media engagement, data visualisation trainings and user-producer dialogues.
- A3. Reporting the use of gender data** (and its value) in national newspaper archives and policy documents, particularly national development plans.
- A4. Reporting of financial resources** for gender statistics through gender chapter in the 2018 Partner Report on Support to Statistics (PRESS) and one special issue.

- Geographical representation, geographical classification (SIDS, Landlocked, LDC)
- Pathfinder country status
- Status of National Statistics Development Strategy
- Potential for synergy with Paris 21 activities (SDMX, visualization, leadership) to ensure better monitoring and greater impact
- Other development partners active in gender statistics/statistical development
- Statistical Capacity Indicator diversity in terms of capacity
- Internal Paris 21 capacity score (Country prioritisation tool)
- Qualitative information - Key informant interviews

Ongoing collection and review of gender statistics global and regional framework

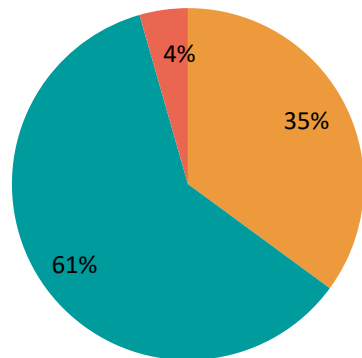

Financing for gender statistics, 2016

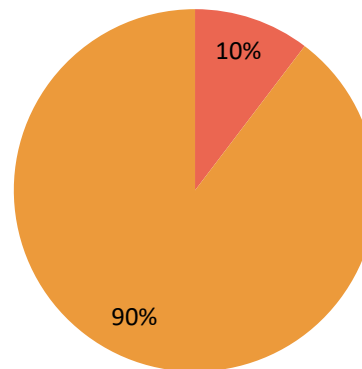
Share of projects with gender statistics component
